Senior Nutrition Program Indoor Dining

The Campbell Senior Nutrition Program reopened for indoor dining on November 1. Approximately 10 seniors have resumed dining indoors while 80 seniors continue to utilize the takeout option. Staff is extremely appreciative of the volunteers from the Rotary Club of Campbell and West Valley Community Corps for their help with meal packaging and distribution.

Medicare Workshop Series

The Campbell Adult Center collaborated with Sourcewise- Health Insurance Counseling Advocacy Program (HICAP) to offer virtual workshops on Medicare benefits. The 3-part series featured topics on Intro to Medicare, Part D (Drug Plan) Finder Demo, and Annual Open Enrollment. HICAP provides health insurance counseling for older adults age 65+ seeking information regarding Medicare and supplemental insurance plans.
