NOTICE OF PUBLIC HEARING
Historic Preservation Board
This meeting will be conducted on Zoom

Notice is hereby given that the Historic Preservation Board of the City of Campbell has set the time of 5:00 p.m., or shortly thereafter, on Wednesday, **February 23, 2021**, for a Public Hearing to consider the application of Michele Babb for a Modification (PLN-2021-23) to a previously approved Historic Resource Alteration Permit (PLN-2020-12) to allow removal of existing siding to be replaced with stucco as part of the ongoing construction of an approximately 800 square-foot rear addition to an Alice Avenue Historic District property commonly known as the Mary Fablinger House, located at **20 Alice Avenue**. Staff is recommending that this project be deemed Categorically Exempt under CEQA.

This Historic Preservation Board meeting will be conducted via telecommunication and is compliant with provisions of the Brown Act and Executive Order N-29-20 issued by the Governor.

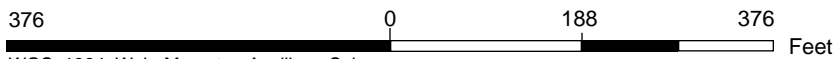
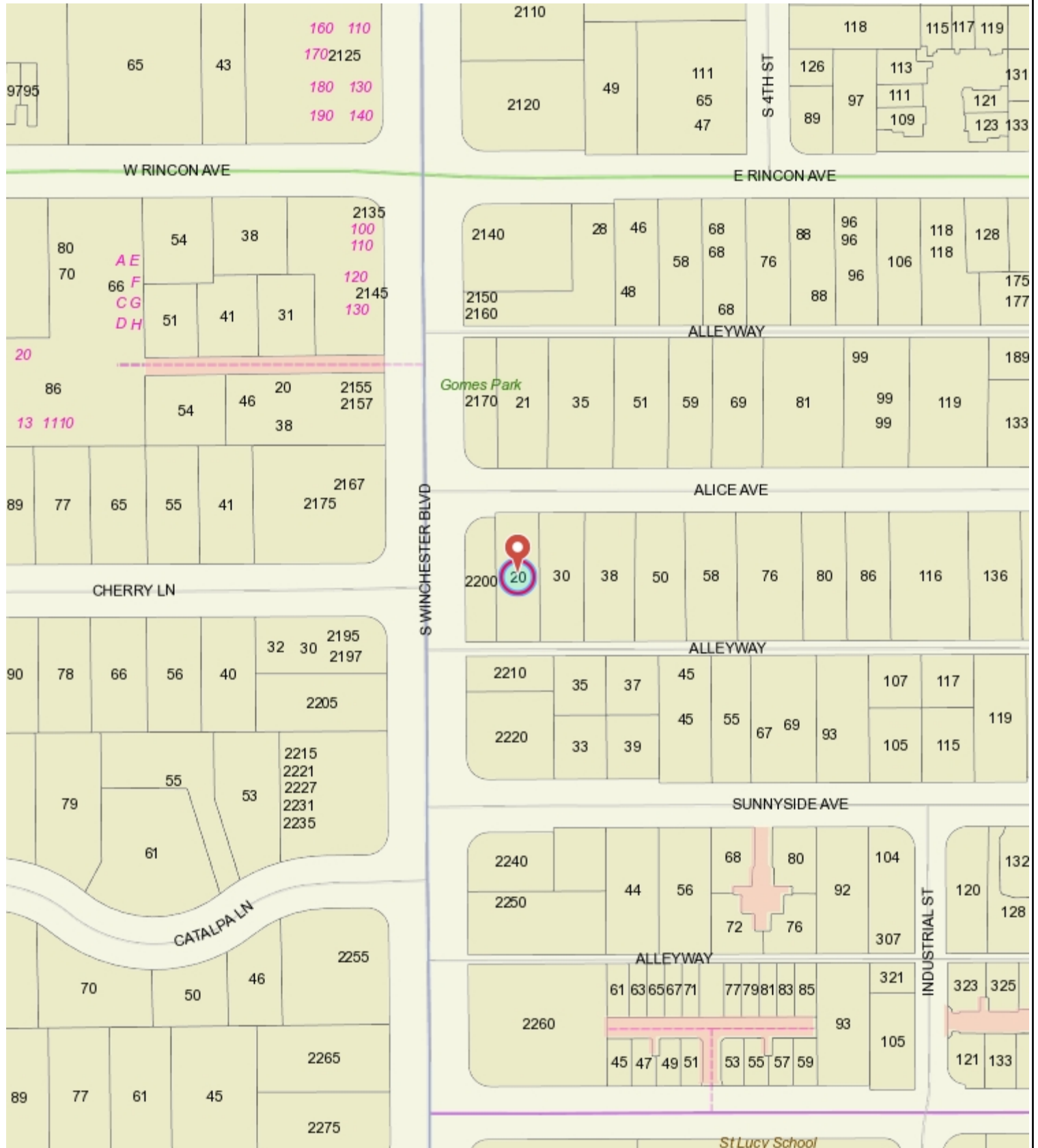
